WHEREAS, Nuts & Volts Electrical of Ontario, New York, submitted a bid proposal dated October 22, 2025, in the amount of \$29,100 for the electrical work associated with the project; and

WHEREAS, the proposal has been reviewed and found to meet the Town's bid specifications and project requirements; now, therefore, be it

WHEREAS, professional design services are required to prepare construction documents and assist with the implementation of the funded improvements; and

WHEREAS, LaBella Associates has submitted a proposal dated November 12, 2025 outlining the scope of design services for the Gravino Park Phase 4 NY Forward project in the amount of \$51,000; and

WHEREAS, the Town of Macedon procurement policy noted in Town Code 55-10 allows companies providing professional services to be hired without a competitive bidding process; now, therefore, be it

RESOLVED, that the Town Board of the Town of Macedon hereby authorizes the Town Supervisor to execute an agreement with LaBella Associates for Design Services related to Gravino Park Phase 4 NY Forward Enhancements as described in the proposal dated November 12, 2025, for a total fee not to exceed \$51,000, subject to Department of State and attorney review; and be it further
