WHEREAS the budget shortfall that would have existed as a result of the increased hourly rate has been eliminated in the two months, we have gone without filling the vacancy,

NOW THEREFORE BE IT RESOLVED that the Department Head of Parks, Buildings and Grounds be authorized to offer a position of full-time employment (40 hours/week) to Timothy Parker, with a probationary period of one year commencing on the agreed start date, should the offer be accepted, and

BE IT FURTHER resolved that the agreed start date must be on or after March 1, 2026, and if the employment offer is not accepted, this authorization is null and void.
